<u>Course Description</u>: The seminar will examine theories of punishment in the larger context of social justice questions. Some consideration will be given to recent empirical research on the relationship between crime, inequality, and incarceration in the United States.

<u>Requirements</u>: Two essays (each 10-12 pages) and one class presentation. First paper due October 31 and second paper due December 12. Prospectus for first paper (300 words) due October 18. Presentation dates to be arranged.
